

Vehicle Parking Waiver & Indemnity Agreement

There are limited parking facilities at the Club for trailer parking at Southlands Riding Club (SRC). In reading and understanding this agreement, the undersigned agrees to all terms of this agreement.

- Trailer owners MUST be at least a SOCIAL Member of the club.
- Parking areas are designated by management and the trailer must be parked in a designated space/stall.
- The parking fee is payable immediately upon the renewal of each thirty-day term. If the owner has not paid the monthly cost by the third day of the 30-day renewable term, their trailer may be towed from the property at the owner's expense.
- Trailers MUST have valid insurance at all times. This insurance shall consist of fire/theft/replacement value. Proof of insurance MUST be supplied prior to parking at SRC and an updated copy provided upon annual renewal.
- The owner acknowledges that the Club may request an owner to move their trailer, with 48-hours notice, to another designated location on SRC property. Circumstances that would warrant trailers to be moved include, but are not limited to, horse shows, clinics, and maintenance of Club facilities. Non-horse trailer members will be moved first.
- If the owner chooses to no longer store their trailer at SRC they must give 15-days notice, otherwise the monthly fee paid will not be refunded.

This information and waiver form must be completed by any person requesting permission to leave their personal horse trailer or other vehicle on the premises of Southlands Riding Club ("SRC").

WHEREAS in consideration of Southlands Riding Club ("SRC") permitting me to park my personal horse trailer or other vehicle (the "Vehicle") on its premises; I hereby release, acquit, and forever discharge SRC, its officers, directors, employees, agents, affiliates, subsidiaries, partners, associates, heirs, administrators, successors, assigns and insurers (collectively referred to as "Southlands Riding Club") without qualification or limitation, from all manner of action, causes of actions, suits, debts, dues, accounts, bonds, covenants, contracts, complaints, claims and demands for damages, monies, losses, indemnity, costs, interest howsoever arising which hereto may be sustained by me in relation to the Vehicle, and from any and all causes of action, causes of action, claims or demands of whatever nature, whether in contract, or in tort arising out of or in any way connected to the Vehicle. AND FOR THE SAID CONSIDERATION I hereby grant SRC the right to remove the Vehicle from its premises where its presence may pose a risk or hazard to SRC or any other persons using the property and release and indemnify SRC from and against any claims, demands, or actions that may result in such removal. Furthermore if such removal is deemed necessary and prudent I agree to pay for all costs related to said removal AND FOR THE SAID CONSIDERATION I agree not to make any claim or take any proceedings against any other person or corporation who might claim, in any manner or forum, contribution or indemnity in common law or in equity, or under the provisions of any statute or regulation, including the Negligence Act and the amendments thereto and/or under any successor legislation thereto, and/or under the Rules of Civil Procedure, from the parties discharged by this waiver and indemnity. AND FOR THE SAID CONSIDERATION I hereby undertake to hold and save harmless and agree to indemnify Southlands Riding Club from and against claims, demands, or actions that may be brought by me or by any other persons on account of damages of any character resulting to me and from and against losses from any and all liability or monetary losses incurred by any or all of them arising as a result of, or in any way connected with the Vehicle during the time that it is present on the property of Southlands Riding Club.
